#### 9. Executive Director's Report

#### <u>Post-Construction Permit-Required Sea Turtle Monitoring:</u>

The District's state permit from the Florida Department of Environmental Protection (FDEP) for sand placement requires that sea turtle nesting be performed following construction. Loggerhead Marinelife Center (LMC) holds the state permit (from Florida Fish and Wildlife Conservation Commission) for performing this work along our section of shoreline. A rate per shoreline length has been established for fulfilling the required nesting for County and Corps nourishment projects. The draft contract is attached.

Commissioner Howard made a MOTION to approve the pending Loggerhead Marine Center contract; Treasurer Davis SECONDED. There being no further discussion, the MOTION CARRIED. 2025 Outlook on Florida Coastal Dredging Projects Workshop:

The FDEP Beaches, Inlets, and Ports Program is conducting a 2025 Outlook on Florida Coastal Dredging Projects Workshop, for Non-Federally Authorized beach or inlet management project that may be coming up within the next ~ 18 months. It will be held prior to the 38th annual National Conference on Beach Preservation Technology (February 5-7, 2025).

The District's project information and timelines have been forwarded and Mr. Chaison intends to attend the workshop ahead of the Florida Shore and Beach Preservation Association (FSBPA) Conference.

Commissioner Howard asked Staff to remember and follow Florida Statutes governing procurement, and to be watchful of behaviors by attendees of the workshop.

#### 2025 Biennial Boat Tour of Loxahatchee River and Jupiter Inlet:

Since 2021, we have conducted a biennial boat tour of the Loxahatchee River and Jupiter Inlet as an opportunity to visit JID projects with our partners and interested public. A 2025 boat tour will allow for adding the completed River Mile 6 project as well as a preview of the Bureau of Land Management's upcoming shoreline stabilization at the Jupiter Lighthouse. This event is best done outside of the summer months, and I want to determine the availability of the Board.

#### **Upcoming Outreach Events:**

#### Nature Conservancy- 2025 Center for Conservation Initiatives Lecture Series

This is a series of five lectures from January through March at the Blowing Rock Preserve. Our Assistant Director is delivering a presentation on Living Shorelines. The series information is included.

Florida Public Archaeology Network - 2025 Jupiter Inlet Lighthouse Outstanding Natural Area Field School
This is an accredited 12-week archaeological fieldwork program at the Jupiter Lighthouse. The JID has been asked to present our Living Shoreline as it relates to cultural resource protection.

#### Friends of Jupiter Beach

The JID will continue its support for the Friends of Jupiter Beach by sponsoring their August 2025 beach cleanup event.

#### Town of Jupiter Centennial Celebration

The Town of Jupiter is celebrating their centennial throughout 2025 with numerous events. Staff have been invited to assist with the Natural Environment Centennial Committee and the Preserving Paradise Presentation on March 19<sup>th</sup>.

#### 2025 Ebb Shoal and Shoreline Evaluation:

Our 1997 Jupiter Inlet Management Plam (IMP) recommends that the JID "Implement a comprehensive beach and offshore monitoring program". Our Sediment Budget update to our IMP has been submitted to the Florida Department of Environmental Protection. That update includes the proposed strategy that "a comprehensive beach and inlet hydrographic monitoring program shall be conducted to evaluate the performance and impact of existing sand bypassing and nourishment projects and to periodically update the inlet sediment budget".

I would like the Board's direction on performing an inlet and shoreline evaluation following the 2025 sand trap dredging and placement.

## Jupiter Inlet District Monthly Engineering Report February 2025

#### **General Engineering**

Jetty Observation

Taylor Engineering staff (Ken Craig) plan to perform the monthly jetty condition assessment on February 12. We will report on any significant changes from the prior assessment.

#### Jupiter Inlet Sand Trap Dredging - 2025

Taylor Engineering advertised the 2025 Sand Trap Dredging project on Friday, January 10, 2025. Bid Addendum 01 was prepared and distributed on Wednesday, January 22, 2025. We plan to open bids on Monday, February 10, 2025, and have an award recommendation at the February board meeting.

#### **Jupiter Inlet Jetties Restoration**

The substantial completion inspection resulted in a punch list that the contractor has addressed. A final inspection is tentatively scheduled for the week of 10 February. Bi-weekly project update meetings have been held every other Wednesday at 2PM.

#### FDEP Local Government Funding Request

Taylor Engineering has submitted the final billing workbook and corresponding deliverables for Grant Agreement #23PB6. FDEP is currently reviewing the billing package and processing the final billing. Once the final billing is complete, JID will receive a reimbursement total of \$1,173,251.49.

Taylor Engineering continues to coordinate with FDEP on Grant Agreement #25PB2, which includes costs for the Sediment Budget Update study and spring 2024 sand trap. The total funding amount to be received under this Agreement is \$736,859.40. Of note, the spring 2024 sand trap project exceeded projected costs by approximately \$390,000.00, so those additional funds will be included in the next Grant Agreement cycle.

#### **FDEP Jupiter Inlet Sand Trap Permitting**

Taylor Engineering is nearing completion of the FDEP Joint Coastal Permit application and will provide a draft to JID for review by the February board meeting.
